Introduction

The South West Group, formed in November 1983, is a Voluntary Regional Organisation of Councils (VROC). In 2008/2009 it comprised the Cities of Cockburn, Fremantle, Melville, and Rockingham, and the Towns of East Fremantle and Kwinana representing 341,162 people and with a Gross Regional Product over \$20 billion.

The Vision and Mission of the South West Group taken from the 2007 – 10 Strategic Plan are:

Local Governments in South Metropolitan Perth, through cooperation with industry, community and the other spheres of government will capture a wide range of opportunities to enhance economic growth as well as supporting a diversity of quality lifestyles whilst servicing and sustaining cohesive, productive communities in an enviable environmental setting.

The South West Group will be persuasive, forward looking and influential in representing, supporting and promoting Local Government interests that affect the growth and sustainable development of South Metropolitan Perth.

Role and Function

The South West Group acts as a regional advocate for the future development and wellbeing of South West Metropolitan Perth and seeks to position local government as a facilitator and senior partner in the future development and decision-making processes in the Region.

This approach seeks to place local government in a more influential position in determining positive outcomes for the Region and the community it serves.

Board of Management – Chairman's Report

The 25th anniversary of the founding of the South West Group has been a very active and productive year.

A major activity has been progressing the South West Corridor Workforce Plan. This project included the Kwinana Recruit, Train and Retain Workshop as well as two briefings on Federal Government workforce surveys carried out in the Australian Marine Complex and the Bibra Light Industrial Area. The Workforce Plan also included extensive regional consultation and 378 surveys of local businesses.

A thirteen member Mayoral Delegation travelled to Canberra in September 2008 which resulted in improved health services for the region and a \$2 million defence schools pathway initiative.

The South West Group successfully sought funds to promote trade development from the Western Australian Government. In November 2008, an agreement was signed with the City of Kota Kinabalu to establish a trade office in Sabah, Malaysia. The Sabah WA Trade Centre was opened in Kota Kinabalu on April 1, 2009.

Shared Services is another project to be supported with Western Australian Government funding. The leading academic in Australia in this field, Professor Brian Dollery, was engaged to assess opportunities for our region. The project is also being advanced by a former regional CEO, Bob Searle. It is very important for our region to assess the opportunities and the frameworks needed to access improvements in service delivery quality to assist local governments respond to the increasing demands from their communities.

In March 2009 the South West Group celebrated its 25th Anniversary with a formal dinner at the City of Melville attended by Jeff Carr who as Minister for Local Government played a key role in founding the South West Group. Also attending were former Chairs, Directors and staff who appreciated the use of quality local produce and the lively entertainment.

The South West Group also assisted the City of Cockburn in arranging the successful Prime Minister's Work Forum held on April 21, 2009.

I wish to thank my colleagues on the Board of the South West Group for the positive approach taken to regional issues and the continuing support provided to the South West Group.

Director's Report

2008/09 sustained the high level of activity of advocacy activity of the South West Group with 13 submissions being made to the Western Australian and Federal Governments and with appearances before 12 committees and inquiries.

Major progress was made on the South West Corridor Workforce Plan and a shared services project commenced. A business plan was developed for the Catalpa Trade Coast and a funding application made to the Federal Government to develop the tourist route.

Celebrating the milestone of 25 years since the foundation of the South West Group was most enjoyable particularly in meeting many of the persons responsible for its creation.

The South West Corridor Development Foundation, the Planning and Infrastructure Committee, the Environment and Services Committee are important components of the operation of the South West Group and I extend my appreciation to Cr Duncan Macphail, Cr Clive Robartson and Cr Christine Halton for their strong engagement with the South West Group throughout the year.

The regional Chambers of Commerce continue to work constructively with the South West Group and I look forward to significant progress on a range of projects in the coming months.

I thank Neil Hartley as Chair of the CEO Forum and Mayor Carol Adams as Chair of the South West Group for their enthusiastic and sustained support throughout the year.

South West Group Mayoral Delegation to Canberra September 2008



The South West Group Mayoral Delegation was led by the Mayor of Cockburn Stephen Lee and included all six regional Mayors and CEOs or acting CEOs from all regional local governments together with the Director of the South West Group, Chris Fitzhardinge.

15 Meetings were held with Ministers, Parliamentary Secretaries, ministerial staff, committee chairs and senior bureaucrats. Important issues tackled by the group included carbon pollution reduction, resolution of an AQIS position on the South Fremantle Landfill site, development offsets, defence industry skills, establishing the South West Corridor as a Federal Government region, regional infrastructure priorities, community security, unemployment, health services and small business development.

Following the Delegation visit to Canberra a number of initiatives were subsequently agreed by the Federal Government. They included:

- the development of the \$2.4 million Maritime Industry School Pathways Program in Western Australia which will provide the maths, science and technical studies students need to pursue a career in the local maritime sector
- Medicare established four Medicare Access Points within the region based on the advice of the South West Group
- funding of \$6.6 million was approved for a GP Super Clinic at Cockburn Central

The formation of the South West Group in 1983 was in the context of high regional unemployment and slow growth. Unemployment in Western Australia was 10.4% at this time. The Town of Kwinana grew only by 27 people between 1981 and 1986 and had unemployment of 15%. The region had great possibilities but had many challenges in service delivery and linking industry to the community.

The then State Minister for Local Government, Jeff Carr and the then Federal Finance Minister, John Dawkins assisted develop a concept of shared funding between State and Federal Governments to establish a local government partnership for job creation.

This concept was considered by regional local governments at a meeting at the Town of Kwinana on November 11, 1983. The meeting resolved to support the concept to cover the entire South West Corridor.

\$15,000 in Federal Funds was sourced from the Department of Territories and Local Government, through Minister Tom Uren, to initiate the South West Group.

Merv Cowan the Town Clerk of East Fremantle was elected as the inaugural Chairman and Mike Fraser, Deputy Town Clerk of Kwinana was elected as the inaugural Secretary. Rick Grounds was appointed as the inaugural Director on March 6, 1984.

On March 6, 2009 eighty people with personal connections to the South West Group gathered to acknowledge the individuals who used their expertise, networks and enthusiasm to drive the success of the South West Group as well as to celebrate the 25th anniversary of the Group.

Those present included Jeff Carr, the former State Minister for Local Government, who supported the creation of the South West Group with Garry Hunt, Bob Smillie, John McNally and Barry Sammels who had chaired the group for a combined total of 20 years. Former South West Group Directors Jan Grimoldby, Geoff Glass and John McIlhone were also at the event.

Members of the meeting that agreed to establish the South West Group on November 11, 1983 that were present were Don Miguel, Tony Armarego, Russ Candy and Bill Thomas.

Susie Langley who was the administration manager of the South West Group for over 15 years and secretary of the South West Corridor Development and Employment Foundation was another guest.

Many other organisations have spun out of the South West Group or formed as a result of advocacy from the South West Group. These organisations were represented by Cr Doug Thompson and Stuart McAll from the South West Regional Council (formed 1992) and Dr Tom Rose from the Cockburn Sound Management Council (formed 2000).

South West Group Sabah WA Trade Centre

Over the last two years, in conjunction with the City of Rockingham, the South West Group has sought opportunities to develop region to region bilateral trade opportunities with the Malaysian State of Sabah and more particularly Kota Kinabalu.

As part of this process reciprocal visits were organised by the City of Rockingham, on behalf of the South West Metropolitan Perth Corridor and the City of Kota Kinabalu (DBKK), representing Sabah which included business interest representation.

A Friendship City agreement between the City of Rockingham and the City of Kota Kinabalu has been signed which will underpin the necessary foundations for trade between firms in the two regions.

The South West Group and its partners have always envisaged that bilateral trade would best be enabled by the establishment of trade centres in both the South West Metropolitan Perth Corridor and Sabah. To this end meetings were held with senior government, commercial and industry officials in both Perth and Sabah, ultimately culminating in a unanimous agreement to advance the project on November 4, 2008.
