Overview of Key Budget Priorities for South West Group

- The South West Metropolitan Region is a key economic driver for the State (Ports, airport, freight rail, passenger rail, proposed intermodal terminal, activity centres)
- Western Trade Coast \$15.5B in annual output, \$1 in every \$7 in WA earned in the region (\$20B annually)
- Strategic and integrated approach to infrastructure planning, coordination and delivery is required

Regional Transport Issues and the Economic Cost of Congestion

- Over 50% population growth in next 20 years south of Perth, with the majority to be accommodated in the South West Metropolitan Region
- Congestion currently estimated to cost \$250-\$300M annually in lost productivity (\$500-\$550M annually in next 10 years)
- The level of investment identified for the region in the Public Transport Plan for Perth 2031 is greatly inadequate
- Greater planning, coordination and investment in regional transport infrastructure is required, including the establishment of light rail networks
- The South West Group is seeking to partner with the State Government to develop a Regional Integrated Transport and Land Use Strategy for the South West Metropolitan Region



Establishing Improved Links with the WAPC Infrastructure Coordinating Committee

- WAPC ICC the peak committee overseeing transport and infrastructure provision in WA
- Outcomes of South West Group presentation to the WAPC ICC
- Proposed to work with the Western Trade Coast industries Committee to identifying ways to influence WAPC ICC to pro-actively address infrastructure challenges in the region, particularly for proposed port and an effective road and rail network
- The ultimate aim is to find ways to partner with State Government agencies to develop a Regional Integrated Transport and Land Use Strategy for the South West Metropolitan Region



Acknowledging and promoting State Government for investment in the region (infrastructure, projects, initiatives)

- Identification of key projects and initiatives over the next 12 months
- Opportunities to acknowledge and promote the achievements of the State Government
- Supporting role of the South West Group and member Councils in celebrating successful outcomes in the region
