## RE: ONGOING INTEREST IN DISCUSSING A CITY DEAL FOR SOUTH-WEST METROPOLITAN PERTH

I refer to three letters sent to the State Government by the South West Group on 6 July 2018 ('City Deals - registration of interest from the South West Group'), 14 August 2018 ('Perth City Deals Update'), and 5 July 2019 ('Proposal for Government investment and partnerships').

The purpose of this letter is to request clarity from the State Government regarding its process and criteria for determining how City Deals are developed in Western Australia. We noted the announcement of a City Deal for Perth City earlier this year and we are requesting clarity on how this decision was made. There appears to be an absence of a transparent, clear and competitive process whereby Local Governments openly compete for the allocation of public funds.

In other States, City Deals have involved groupings of several Local Governments, such as the Western Sydney City Deal - a 20-year partnership between the Australian Government, NSW Government, and several Local Governments. They are, after all, City Deals and not 'Capital City Deals'.

As outlined in the aforementioned letters sent to the State Government, the South West Group has been eager to hold discussions with the State Government to explore the potential of a City Deal for the South West Metropolitan Region. To prompt such a discussion we developed a proposal titled *'Proposal for Government Investment and Partnerships'* that was provided to the State Government more than one year ago. As explained at the time, that document was intended as a starting point for collaboration and not a definitive proposal.

We believe that other grouping of Local Governments such as the East Metropolitan Regional Council have made similar efforts but have not received clarity on the process or criteria.

We would appreciate clarity on this matter.

## Perth City Deals - registration of interest from the South West Group

Thank you for your time on the 26<sup>th</sup> June to discuss the 'Perth City Deal' and the opportunities that it may present for the South West metropolitan region. As you know, the South West Group was established in 1983 as a co-operative venture of six Local Governments in the South West region: it includes Cockburn, East Fremantle, Fremantle, Kwinana, Melville, and Rockingham.

One of my roles as Director of the South West Group is to attract a greater level of public and private investment to the region. I understand from our conversation that the Perth City Deal is a 'live opportunity' and that the DPC are currently exploring delivery options and potential partnerships. I would like to formally register the South West Group's interest in engaging with the DPC on the project, with the goal of developing a high level document that outlines the intended outcomes, principles and indicative contributions from member Local Governments in the South West metropolitan region.

I would like to highlight the benefits for the DPC in working with the South West Group as a long-standing and respected organisation that works to progress the common interests of its member Local Governments. Furthermore, as exploring this opportunity is a priority for me as Director, I can offer South West Group resources by way of my time and potentially a budget for consultants to explore the opportunity in more detail if required.

I am expecting to meet with the member Council CEOs by the end of this month - the purpose of that meeting is to explore the different scenarios for a City Deal that includes the South West metropolitan region. I will report back to you with the outcomes of that meeting.
