

Regional NRM Facilitator Project Summary Report January 2017 - December 2019

The Regional Natural Resource Management (NRM) Facilitator is a part time (0.5 FTE) contractor role.

Initiated to assist contributing^{*} member Councils to achieve improved NRM outcomes, the role has added value to the work being done by member Council environmental officers by focusing on addressing issues that are common to multiple Councils such as:

- brokering partnerships
- instigating, coordinating and managing regional scale, multi-stakeholder projects
- leveraging external funding and in-kind contributions that would be otherwise be difficult for individual Councils to identify and consolidate
- engaging with other land managers to improve the coordination and management of natural areas
- actively contributing to the achievement of member Council NRM objectives.

This report summarises key achievements for the 3 year contract from Jan 2017 – Dec 2019.

^a The Regional NRM Facilitator was asked to trial providing climate change adaption and coordination support to member Councils in 2017, guided by the South West Group Framework for Regional Approach to Climate Change Adaptation (Phase 1) and outcomes of the associated workshop. Uptake from member Councils was limited, so this support was continued on a limited and purely opportunistic basis through 2018 and 2019.
